We urge you to apply early, as space is limited and are on a first-come, first-served basis.

2022 Parade Theme: Spirit of Christmas

Location: Staging- Altavista High School Bedford Avenue

ATV Clubs will stage at Fellars back lot. Enter off of 5th Street.

Parade Date & Time: Saturday December 3rd, 5pm

Entry setup time: 2 - 4pm (all entries must be parked/staged in place by 4pm NO Exceptions)

Parade Route/ Advisory Notes: Parade entries will be parked/ staged around Altavista High School. Parade route makes several turns: Bedford Ave to left on 7th St; 7th St to right on Broad St; Broad left on Main Street. It is recommended that total length be less than 45 feet.

Height of entry must be less than 12' to clear the Bedford Avenue underpass.

Entries may start staging by 2:00 and must be in place by 4:00 and ready to begin parade at 4:45

Parade Representatives: We request each group designate one person as their "parade representative" who will help with coordination of each group during setup/ staging and to be the point of contact for any questions before and or during the event. Parade representatives will report to parade check-in for entry verification on the day of the parade. You will receive a parade packets and entry numbers via email prior to the event. (Parade packets will NOT be mailed this year.) The information in these packets is essential and includes your entry number that will go on your entry. If you have any questions concerning your packet, please email bev@altavistachamber.com

Signs/ Banners/Logos: Entries must have a clear, sign that reflects the applicant. No other group or business may be promoted on the sign. The Chamber reserves the right to remove any entry that represents any for-profit endeavor other than what is listed on the participant's application.

Waiver of liability: Any person entering the event/ parade does so at his/her own risk, bearing all liability for any and all damages or loss of personal property and/or any personal injuries sustained to themselves or other person(s). Entries into the parade/ event hereby waives all claims and or defenses it may have against the Chamber of whatever kind or nature as a result of his or her independent actions.

Etiquette: The Parade is for the entire community. Please keep all costumes and clothing choices suitable for family viewing. Please listen to all information and follow directions of the event staff during set-up, parade staging, execution, and disassembly. Parade/event staff are there for your safety and security. Please be respectful and do NOT leave any trash behind.

Disclaimer: The Chamber hereby absolves any liability arising from use of floats in the parade or any activities in association with the Chamber. In accordance with City, State, and Federal laws, no alcoholic beverages allowed during any portion of the Parade. In addition, no person under the influence of alcohol or drugs shall be allowed to operate a motor vehicle during the parade. The Chamber reserves the right to remove, including but not limited to, any person, motorized or un-motorized vehicle, conveyance, float, or participant(s) for any activity deemed unsafe, violation of any rules contained herein, or action or inaction that may cause any delay to the progress of the parade. The Chamber attempts to accommodate all requests for parade placement; however, parade placement is at the sole discretion of Chamber and



the Parade Committee, and such placements are final.

Security: The Altavista Police Department is responsible for enforcing applicable state laws and local ordinances during the Altavista Christmas Parade. Such statutes may include, but are not limited to public decency, alcohol, controlled substances, public safety, and standard vehicle insurance requirements.

Floats / displays: The Chamber would like to encourage groups to highlight their organization/business through a float or festive display. It is the one time of the year you can promote yourselves in front of the entire community. You may be surprised at the interest and excitement an entry in the Altavista Christmas Parade can give to your organization.

- No Mr. or Mrs. Santa Claus costumes are permitted except for the official Mr. & Mrs. Santa Clause appointed by the Chamber.
- For safety reason, <u>no one is allowed to throw candy to the crowd</u>. However, walkers alongside entries may hand out candy.
- All parade entries must be decorated for the holiday season, including company vehicles, antique
 cars, ATVs/4 Wheelers, and motorcycles. Business entries need to add to the entertainment value
 of the parade and adhere to the theme. Entries that arrive with no decorations will not be permitted
 to participate.
- All drivers must hold a valid driver's license and valid/adequate insurance coverage. ATV and
 motorcycle drivers and riders MUST wear their helmets rules of road apply to the parade no
 wheelies, hot rodding, slowing down and then speeding up, or other inappropriate activities.
- Minor children must be accompanied by adults.
- Any and all music played must be family friendly. No vulgar, racial or sexual content allowed!
 Volume must be kept at an appropriate level (marching bands are exempt from this requirement).
- A fire extinguisher must be on board each float/vehicle.
- All entries must clearly display the name of organization/business.
- Entries that include live animals must call the Chamber of Commerce for approval, 434-369-6665.
 Animal handlers must be prepared to clean up after their animals. All waste must be removed immediately from the staging area and from the street so others do not have to walk in or around it.
